In order to continue our progress to achieving Net Zero, we have adopted the following Carbon Reduction Targets.

The following environmental management measures and projects have been completed or implemented since the 2022 baseline. The carbon emission reduction achieved by these schemes equate to 5,194 tCO₂e, a 10% reduction against the 2022 baseline and the measures will be in effect when performing the contract

Our completed Carbon Reduction Reducing Actions include

- Management meetings, staff reviews, DWP PCAB Meetings have been undertaken by ZOOM or • Microsoft Teams
- Audits have been instigated to measure and monitor the amount of paper being used and recycled (reports from Data shred provide the level/number of CO2/water/trees saved)
- Audits measuring and monitoring staff travel have been instigated
- Staff have advised to turn the temperature of heating down by 2°C in delivery centres
- Staff and customers are reminded to reuse, recycle, reduce and recycling points / containers are clearly • signposted
- IT all computers are fitted with solid state drives to reduce the amount of energy used
- We have installed 'green' water coolers supplied by Aqua-aid bottles and cups totally recyclable, automatic donation to charity supporting Christian Aid and The African Trust
- We are currently investigating registering/achieving recognised environmental management accreditation

In the future we hope to implement further measures such as:

- Reducing the amount of staff travel by ensuring all delivery sites are accessible by public • transport and promoting car share
- Instigating Environmental Management Scheme and gaining accreditation e.g., ISO14001 •
- Sourcing low carbon energy suppliers and monitoring energy and water use •
- Purchasing recycled paper and discourage printing •
